Canaan Township Board of Trustees Regular Meeting December 9, 2019 Minutes

Chairman Matt Carwell called the meeting to order at 7:30 PM. Roll call showed all trustees and the fiscal officer present. Also present were Billie Pangborn, Regional Planning Representative, Andrew Wick, candidate for Morrow County Prosecutor, Mike Goff, candidate for Morrow County Treasurer, and Tim Siegfried, candidate for Morrow County Commissioner.

Mr. Goff shared that he has been in the treasurer's office for a little over a year and is completing an unexpired term. He will be on the primary ballot in the spring and as of this date is running unopposed. Mr. Goff is a 1976 graduate of Mt. Gilead. He said his top priority is the protection of county money. The county is also on pace to collect 24% of delinquent taxes this year. Mr. Goff said the county presently has over 3 million in delinquent taxes.

Mr. Tim Siegfried shared that he is running for Morrow County Commissioner against current commissioner Burgess Castle. Mr. Siegfried is a 1976 graduate of Mt. Gilead and grew up in the Iberia and Edison areas and currently resides in Marengo. He is a retired educator, ending his career in the River Valley School System.

The fiscal officer presented the minutes from the November 11, 2019 regular meeting. Mr. Sayers made the motion to approve the minutes. Mr. Bayles seconded the motion. Motion passed.

The fiscal officer reported receipts and balances to date in all funds. The bank reconciliation report was also presented. Automatic drafts were examined. The United Bank Statement was also distributed. Credit card purchases for November and early December were reviewed and the attestation statement signed by Mr. Carwell. Mr. Bayles made the motion to approve the reports. Mr. Sayers seconded the motion. Motion passed.

Mrs. Retterer reported that the \$500 check for the MORE Grant was received on December 5, 2019. This will help cover the reflective road signs purchased from Hartman's Printing.

- Ohio EP Class B Biosolids Beneficial Use Site Authorization: The Ohio EPA authorized approximately 23-acres beneficial use site, owned and operated by Michael and Nicole Sayers, located on the north side of CR 67 between CR 60 and CR 66. This site is to be included as part of the Caledonia WWTP Class B Biosolids Management Program.

David King Sayers, brother of Ed Sayers, was buried in Worden cemetery on Saturday, November 23, 2019.

The trustees checked all the roads on December 4, 2019. The Road Sign Inventory and Management form was completed and is on file. The sign and post on TR 39 has been knocked over by a vehicle and will need to be replaced.

Mrs. Pangborn, Regional Planning Representative, reported there is nothing new affecting Canaan Township. However, the board did discuss changing the zoning for McCreary's Body Shop in Mt. Gilead form residential/agricultural to industrial or commercial. It has been zoned this way for over 43 years. The board has decided to leave the final decision for re-zoning up to the Morrow County Commissioner's.

Mr. Sayers reported that the levy for First Consolidated to build a new fire station on State Route 98 just south of State Route 95 will be placed back on the ballot in the spring. There is an open meeting on Wednesday, December 11, 2019 to discuss this. The next regular scheduled meeting is Monday December 16, 2019.

Mr. Carwell is still waiting on a call back from Ag-Pro to discuss the invoice (\$1,591.11) for the Kuhn mower repair back in September. The repairs made were not successful. The trustees discussed setting a time to go in and speak to Ag-Pro in person about their concerns.

The application for the Indigient Burial Reimbursement for Michael L. Belt was completed online on December 4, 2019. If reimbursed, the township would receive \$1,000 back from the state for the funeral expenses the township incurred for Mr. Belt.

Mileage reimbursement will be the same as the IRS rate for 2020.

Mr. Sayers made the motion to approve the bills for payment. Mr. Bayles seconded the motion. Motion passed.

There being no further business to come before the board, Mr. Carwell made the motion to adjourn. Mr. Sayers seconded the motion. Motion passed. The meeting adjourned at 9:10 PM.
