Mr. Bayles moved the adoption of the following Resolution:

BE IT RESOLVED by the *Board of Trustees* of Canaan Township,

CULVERT AND DRIVEWAY ENTRANCE PERMIT POLICY

1. Residential driveway Culverts must be 8 inches or larger in diameter and at least 30 feet long.
2. Tile for the purpose of filling in front yard ditches must be 6 inches or larger in diameter.
3. Canaan Township Trustees will no longer provide stone for driveway culverts.
4. Agricultural driveway culverts must be 8 inches or larger and at least 40 feet long.

For any of the above the permit form shown below must be completed in duplicate and the site inspected by a trustee before any culvert is installed.

If a culvert is installed improperly and/or with an incorrect size of culvert the Trustees may require the reinstallation by the property owner according to proper specifications. If the property owner refuses to reinstall the culvert properly, the trustees may contract to have the culvert removed and all costs may be filed with the county auditor for assessment on the tax bill for the real estate parcel.
