Mr. Carwell moved the adoption of the following Resolution:

**BE IT RESOLVED** by the *Board of Trustees* of Canaan Township,

# Healthcare Insurance Reimbursement Canaan Township, Morrow County, Ohio

Whereas township has offered/procured a health insurance policy as required by the ACA that has been declined and therefore, per the ACA, the township will reimburse to each declining official the cost of the health insurance premiums for the other ACA approved health care coverages that each carries. The reimbursement will be for insurance premiums paid by the officials for policies that my provide benefits for hospitalization, surgical care, major medical care, disability, dental care, eye care, medical care, hearing aids, prescription drugs, or sickness and accident insurance, or a combination of any of the foregoing types of insurance for township officers and employees. The total of payments for each official or employee in a calendar year shall not exceed \$5,000 per year per individual or a total of \$10,000 per year for those who would be eligible for a family plan, payable upon receipt of a statement of the insurance premiums paid and copies of receipts or proofs of payments each month or quarter or any other period the official chooses to use for submission. All payments made in a calendar year must be submitted by December 31 of the year they were paid.

The township may not reimburse officers and employees for benefits other than those listed in division (A) of section 505.60 of the Revised Code.

When all officials were asked if they wished to sign up for or accept the health insurance plan offered by the township they answered as below:
